**SUBJECT:** Revisions to Cemetery By-law

**Recommendation:**

WHEREAS the Council of the Township of Lake of Bays receives the staff report "Revisions to Cemetery By-law" dated June 9<sup>th</sup>, 2009; and

THEREFORE BE IT RESOLVED THAT a by-law to provide for rules and regulations for the care and control of all municipal cemeteries be APPROVED and submitted to the Registrar of the Cemeteries Branch pursuant to the Cemeteries Act for their approval.

**Background:**

The following revisions to the existing Cemetery By-law were approved by the Cemetery Committees at their meeting held April 20<sup>th</sup>, 2009:

I. **New Section**

Schedule "C" – List of Municipal Cemeteries and their status

II. **Rules & Regulations**

Schedule "A" – to be revised as follows:

a) **Section 7 (4)** – shall be re-written as follows:

Existing	No monument or marker shall be installed without payment of the required fees having been paid to the Corporation and a receipt has been issued to the purchaser.
Proposed	No monument or marker shall be installed without payment of the required fees having been paid to the Corporation, <b><i>along with copy of monument/marker arrangements as set out in Section 3</i></b> , and a receipt has been issued to the purchaser.

- b) Section 10 (1) – shall be re-written as follows subject to discussion with respect to having Summer/Winter hours:

Existing	Visitors are welcome at the Cemetery during daylight hours. Visitors are requested to respect the deceased and conduct themselves accordingly.
Proposed	<b><i>The Cemetery will open for visitors daily from 8:00 a.m. to 8:00 p.m.</i></b> Visitors are requested to respect the deceased and conduct themselves accordingly.

III. Schedule of Rates

Schedule "B" – to be revised as follows:

- a) Corner Markers – set of four (4) Corner Stones (based on actual costs)

Existing	\$100 + GST	Proposed	<b>\$125 + GST</b>

- b) Plots - Suggest 2010 rate increase in plot prices by 3.5%

- c) Cremation Plots – suggested price of 2"x5" cremation plots at Paint Lake Cemetery and Stewart Memorial Cemetery be \$315 for ratepayers and \$525 for non-ratepayers
