THE PURPOSE of the Public Hearing will be to consider a proposed amendment to the Official Plan of the Township of Lake of Bays (**OPA No. 8 – Paint Lake Plan**), pursuant to the provisions of Section 17 of the Planning Act, R.S.O. 1990, Chapter P.13.

ANY PERSON OR AGENCY may attend and provide representation at the Public Meeting and/or make written representation prior to the meeting, either in support of, or in opposition to, the proposed Official Plan Amendment.

IF YOU WISH TO BE NOTIFIED of the adoption of the proposed Official Plan Amendment, you must make written request to Michelle Percival, Clerk at the Township of Lake of Bays (see address below).

IF A PERSON OR PUBLIC BODY THAT FILES AN APPEAL OF A DECISION of the Township of Lake of Bays in respect of the proposed Official Plan Amendment does not make oral submissions at the public meeting or make written submissions to the Township of Lake of Bays before the proposed amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED OFFICIAL PLAN AMENDMENT:

An application to amend the Township of Lake of Bays Official Plan, as amended, has been initiated by the Paint Lake Association. The proposed amendment affects lands identified within the watershed of Paint Lake, together with those lands directly abutting Paint Lake.

Specifically, the proposed amendment will add general policies to Section H (Waterfront) to identify and implement the unique characteristics of the Paint Lake area and Lake Plan.

THE PROPOSED AMENDMENT will affect lands within the Paint Lake watershed as generally identified on the attached key map.
