THE PURPOSE of the Public Hearing will be to consider two proposed amendments to the Official Plan of the Township of Lake of Bays (**OPA No. 10 – Menominee Lake Plan AND OPA No. 11 – Raven Lake Plan**), pursuant to the provisions of Section 17 of the Planning Act, R.S.O. 1990, Chapter P.13.

ANY PERSON OR AGENCY may attend and provide representation at the Public Meeting and/or make written representation prior to the meeting, either in support of, or in opposition to, the proposed Official Plan Amendment.

IF YOU WISH TO BE NOTIFIED of the adoption of the proposed Official Plan Amendment, you must make written request to Michelle Percival, Clerk at the Township of Lake of Bays (see address below).

IF A PERSON OR PUBLIC BODY THAT FILES AN APPEAL OF A DECISION of the Township of Lake of Bays in respect of the proposed Official Plan Amendment does not make oral submissions at the public meeting or make written submissions to the Township of Lake of Bays before the proposed amendment is adopted, the Ontario Municipal Board may dismiss all or part of the appeal.

**EXPLANATION OF THE PURPOSE AND EFFECT OF THE PROPOSED
OFFICIAL PLAN AMENDMENTS:**


Applications to amend the Township of Lake of Bays Official Plan, as amended, have been initiated by both the Menominee Lake Association and the Raven Lake Association respectively. The proposed amendments affect lands identified within the surrounding watershed and those lands directly abutting Menominee and Raven Lakes.

Specifically, the proposed amendments will add general policies to Section H (Waterfront) of the Official Plan to identify and implement the unique characteristics of the Menominee and Raven Lake areas and their respective Lake Plans.

THE PROPOSED AMENDMENT will affect lands within the Menominee and Raven Lake watersheds. The key map is available at the Township Office.

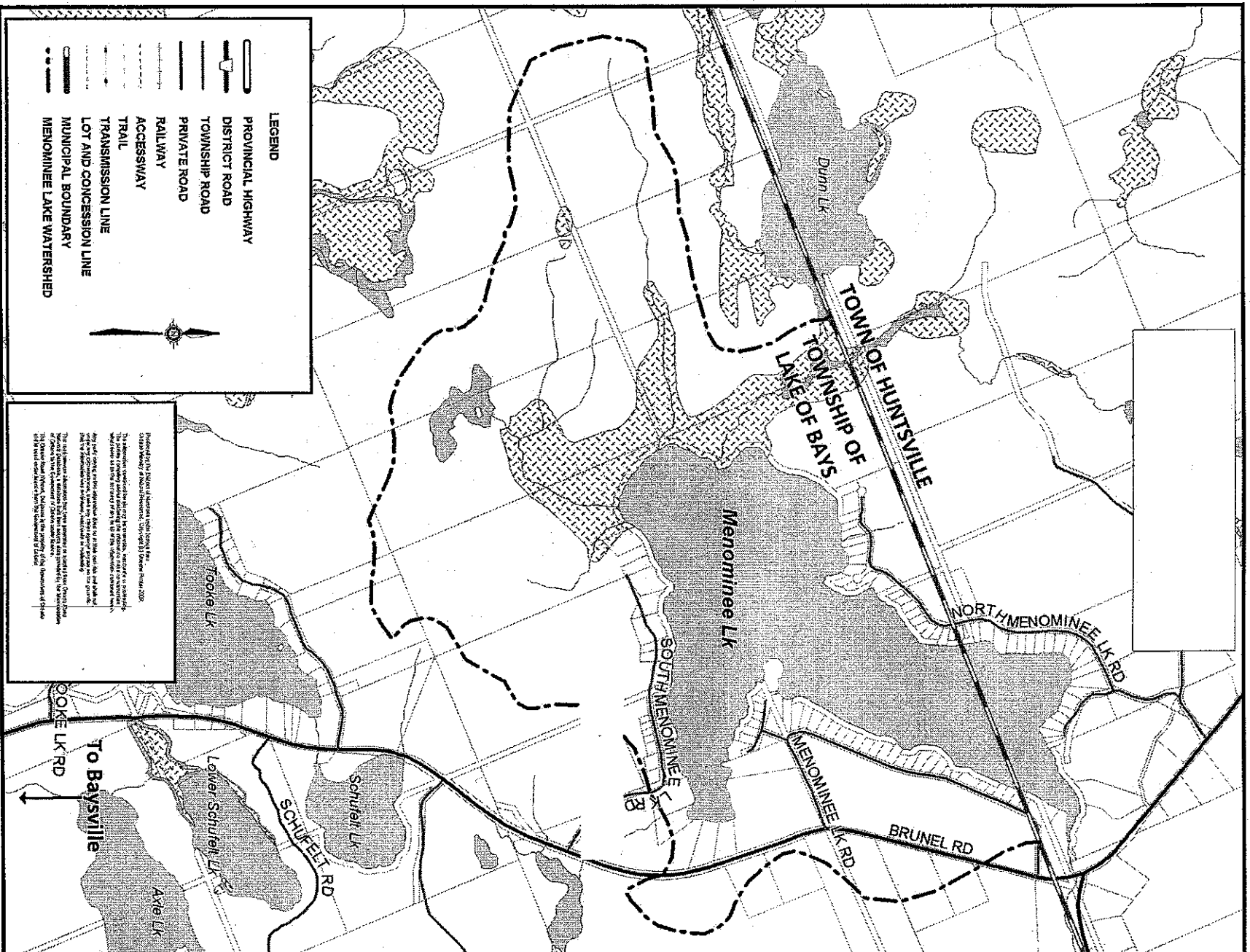

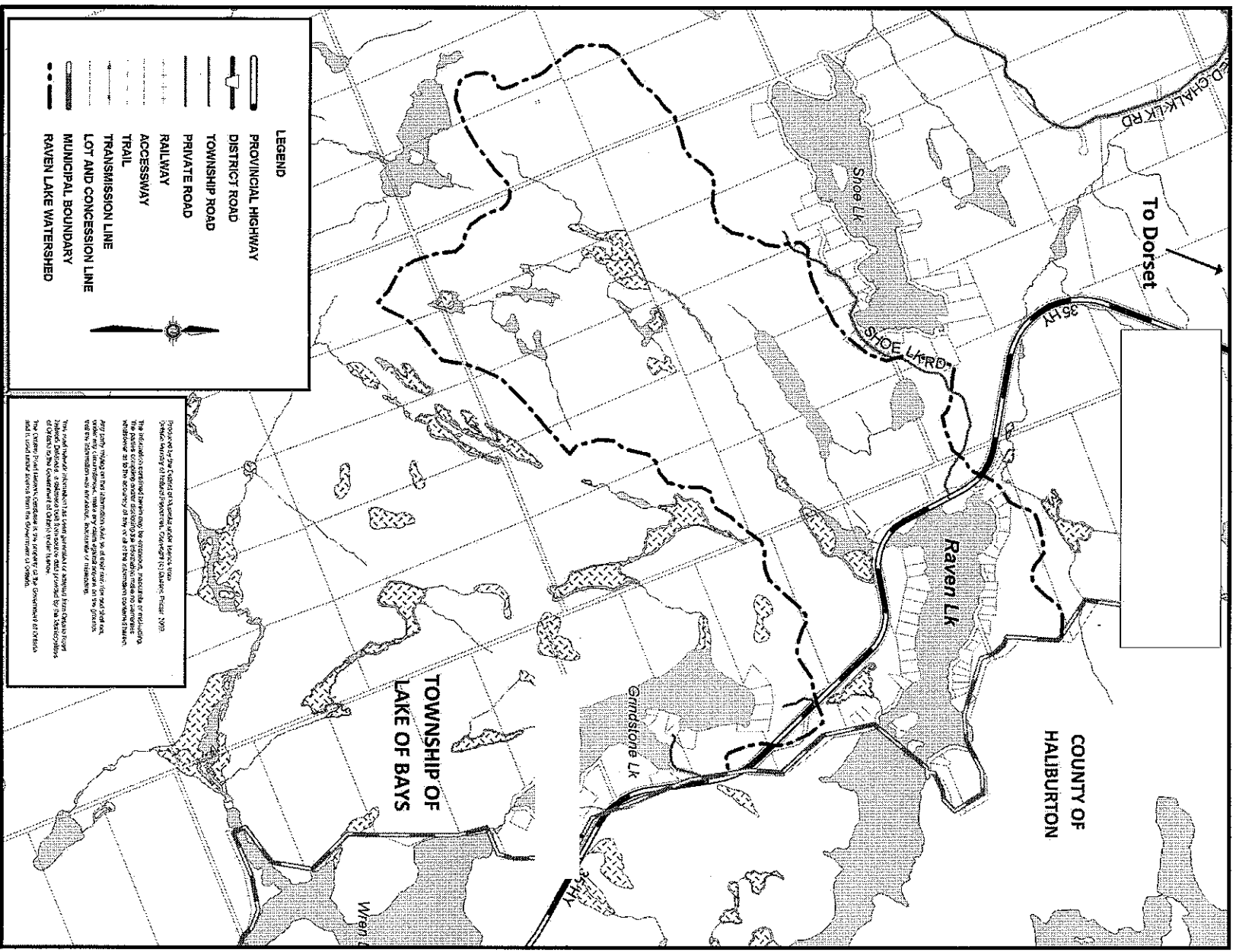
