LATE PAYMENT

A penalty of 1.25% is added on the first day of each month that taxes remain unpaid. It is the taxpayer's responsibility to ensure payment is received at the Township of Lake of Bays by the due date to avoid penalty charges. Failure to receive a tax bill does not entitle the taxpayer to an extension of the due date nor cancellation of late payment charges. Allow 10 days for mail delivery.

2010 INTERIM TAX BILL

If you will be away when the 2010 interim is mailed and/or due you may wish to send post-dated cheque(s) for the February 26, and April 26, 2010, proposed due date(s), and we will process your payment.

METHOD OF PAYMENT

1. **Telephone/Internet Bill Payment Service:** Please contact your Financial Institution. Provide the property roll number at the time payment is made (i.e. Lake of Bays Township Taxes 44-27-000-000-00000-0000) to ensure credit to the correct account.
2. **Pre-Authorized Payment**
Monthly or Installment Enrollment deadline is October 30, 2009 for the 2010 taxation year.
3. **Mortgage Companies**
If your mortgage company pays your taxes, this bill has been forwarded to them. Please retain your copy for your records.
4. **Post-Dated Cheques**
Will be accepted for the due dates.
5. **By Mail:**
Make cheques payable to the Township of Lake of Bays.
6. **In Person**
At the cashier's counter.
7. **Financial Institutions**
Remit at most major banks.

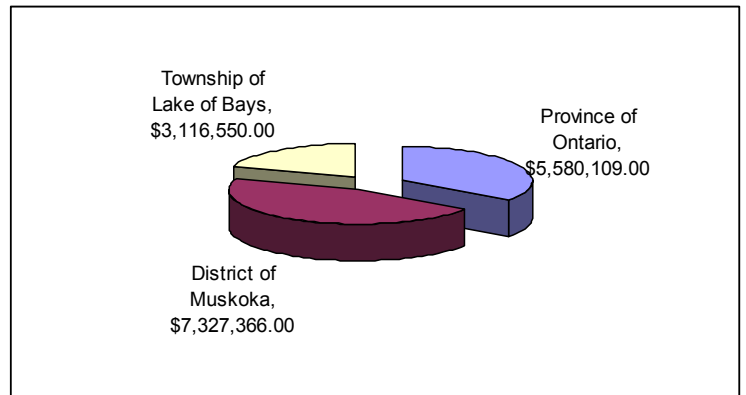
